

# **CIO Forum**

October 15, 2019

#### Welcome and introductions

Advisory Council Vice Chair Michelle Tuscher, State Board of Accountancy, opened the meeting. Michelle stated the Advisory Council will have two spots available for medium size agency representation as of November 1. WaTech Director and State CIO Jim Weaver will request nominations from the medium size agency Director's. Once the nominations have been received, the medium size agencies CIOs will vote on who to represent them.

### Adobe's Large Government Agency (LGA) Agreement, Greg Tudor, RCO

DES announced Washington State participation in Adobe's LGA agreement in Nov 2018. The LGA gives discounts on Document Cloud licenses such as Adobe Acrobat Pro and Creative Cloud. The discount is based on the total number of licenses of the state. In March, the state discount for Acrobat was about 20%, and had increased to 46% by September. To enroll in the LGA, participants must purchase at least 100 licenses. Greg asked whether small agencies could pool their license purchase. All agencies must pool their orders under a single value-added reseller, and one agency must administer the LGA. Only SHI had pooled small agency licenses in Wisconsin. RCO put together a group of small agencies that needed 100 licenses (BIIA, PSP, RCO, and SCC). Each agency references the RCO LGA, gets their own quote from SHI, and pays their own PO. RCO creates a group and assigns an agency administrator for each agency to manage its own licenses and users. Agencies interested in joining RCO's LGA must contact Greg before ordering.

# E-Signature Update, Greg Tudor, RCO

RCO and PSP also asked OCS for a security design review of an e-signature product from Adobe (Adobe Sign). OCS has now approved Adobe Sign for use. We expect the product to be on the OCS ASK site soon (<a href="https://watech.sp.wa.gov/ocs/SPC/SitePages/Customer%20Resources.aspx/">https://watech.sp.wa.gov/ocs/SPC/SitePages/Customer%20Resources.aspx/</a>) with directions for other agencies to use.
