Jennifer Rosales, ISG, gave a brief overview of provided attachments as deliverables from strategic consulting engagement.

Office 365 – Tenancy and Name Space

Discussion points:

- What is the business case for each tenant option, and for separate tenant requests?
- What is the criteria for tenancy?
- How would policies around standardization be helpful?
- What are the individual agency requirements related to tenancy?
- Does maintaining centralized EAD forest for the next 5+ years bring value? Key considerations include visibility and collaboration among state employees, interconnection with other cloud-based services, and flexibility outside of Microsoft for office application suite solutions.
- What are the security risks of shared and multitenant?
- What changes will result in a business risk transference to/from a state agency to WaTech?
- What are the public records implications for tenant options?
- What are the compliance issues for tenant options?
- For the agencies with existing tenants active outside the shared tenant, what are the considerations for reregistering, at least for the interim period, within the shared tenant to enable hybrid directory synchronization and enable Skype Online and Exchange Online?
- What are the roles specific to the Global Administrator of the shared tenant that cannot be delegated to the Agency Administrator? What are the features and functions that must be enabled only at the tenant level and cannot be enabled/disabled at the agency level?

The Council agreed that more input was needed from the broader CIO community, including specific input from agencies with tenants registered and active outside the shared tenant currently.

CIO Forum Agenda

The Council agreed that Chris Lamb, as Chair of the Council, would run the February 19 CIO Forum meeting. Suggested agenda items are: Council introductions, communication flow, customer value, and O365 including tenancy and name space (what agencies are struggling with, where they are stuck, and what is important).
