

# Integrated Eligibility & Enrollment (IE&E) Modernization Program

#### Vision

We envision a world where HHS Coalition organizations can quickly respond to program, partner, client, and legislative needs, aided by improved technology and business processes."

- An easier experience for Washington residents
- An improved user experience for client and community-based assistors
- An improved experience for eligibility staff and case workers

### **Program & Projects Overview**

The IE&E Modernization Program seeks to enhance the accessibility of health and human services programs for all Washingtonians, fulfilling the goals of the Washington State Health and Human Services Enterprise Coalition (HHS Coalition). Client eligibility, enrollment, and case management for all the programs supported across the HHS Coalition organizations are each dependent on a complex network of legacy system and business processes which presents major challenges for clients, navigators, assisters, and state staff, including redundant data requests, high complexity and interdependency of state system, and legacy customer experiences.

The IE&E Modernization Program is a unique model that includes multiple projects, that make up a program, within a portfolio managed by six agencies, and matrixed resources with a combination of state staff in various agencies and vendor contracts administered within individual agencies.

The IE&E Modernization Program encompasses both maintenance and operations of business-critical systems and cloud-focused transformation of state systems and processes. Using a modular approach, the IE&E Modernization Program is developing a new modern platform in the cloud and modernizing business and technical capabilities and solutions that will be commonly shared across the HHS Coalition agencies and clients.

There are currently eight (8) projects within the scope of the IE&E Modernization Program that support the vision. These projects are occurring simultaneously, and each is aligned to achieve the broader IE&E vision and strategic goals of the IE&E roadmap. Each of the eight projects plays a critical role to either stabilize and ensure a healthy mainframe system (the DSHS Automated Client Eligibility System (ACES complex) or



to establish the modern cloud foundation platform with a focus on modernizing business capabilities to drive the vison and improve the client experience to better serve the residents of Washington.

In Summer 2024, an updated IE&E Modernization Program roadmap will be released that builds on current modernization progress and leverages our greater in-depth architectural understanding of the ACES complex of legacy systems. A detailed project roadmap will also be released for a Health and Human Services portal focused on an improved client experience that will streamline the customer process to apply for and maintain benefits.
