## **Project Summary**

The Resident IAM Modernization project has transitioned into the broader DEX Program, which encompasses multiple initiatives, including the Resident Portal pilot and CIAM.

The program continues to gain momentum with major milestones achieved in onboarding, platform development, identity verification, and security readiness. The team successfully launched the first service integration with the County Road Administration Board's (CRAB) Pinnacle application—**90 days ahead of schedule**—marking a significant step forward in delivering modern, secure digital identity services to Washington residents. Critical decisions were made on user account transition, while work progressed on onboarding, security architecture, and partner engagement. The project remains on track toward the Minimum Viable Product (MVP) launch, with positive feedback from early adopters and growing agency engagement.

#### **Key Accomplishments**

### Service Integration & Early Adoption

- Launched first production integration with CRAB's *Pinnacle* application via Customer Identity Access Management (CIAM) **90** days ahead of schedule.
- Developed internal and user-facing support documentation.
- Initiated knowledge base rollout and administrator onboarding for CRAB.

### • Identity Verification & Security Readiness

- o Identity Verification (IDV) provider engagement continues to progress.
- Completed Security Design Review (SDR) documentation with minor updates.
- Completed updated Security Risk Assessment.
- o Initial CrowdStrike penetration testing completed successfully.

### Architecture, Onboarding & Credentials

 Finalized near-term segmentation approach and long-term CIAM public cloud migration strategy.
